Applications to Be Reviewed for Completeness:

FRANK EDWARDI – Block 241, Lot 2.02 - Located on Fairway Court South off of Route 9 in the Ocean View Center District. Applicant seeking preliminary and final site plan approval and an use variance to construct a 10,400 SF self storage facility with 67 storage units, a 400 SF office building and related site improvements. Various bulk variances are requested.

RIVERVIEW PLUMBING HEATING & COOLING, LLC – Block 225.01, Lot 8.11 – Located on Stoney Court off of Woodbine-Oceanview Road in a Business Zoning District. Applicant seeking preliminary & final site plan approval to construct a 10,00 SF storage/warehouse facility, a 1,650 SF pole barn and related site improvements. Variances for minimum landscape buffer & setback to the freestanding sign are requested.

The work session committee, having reviewed each application listed above with the Board Engineer, will recommend to the Consolidated Land Use Board whether the application should be deemed complete for its consideration.
