Mr. Konczyk commented on previous concerns from the Committee and Committeeman Germanio clarified his concerns. Mr. Konczyk commented on the Committee having business owners and union members on it. Mr. Konczyk commented on supporting unions and acquiring union endorsement with comments from Committeeman VanArtsdalen.

Committeeman Germanio indicated that the Senior Center Director, Mrs. Essig, hasn't been feeling well and that the Movie Night scheduled for June 17 has been cancelled and he extended prayers to her and Paul for a speedy recovery. He that the Drive Thru Luncheon scheduled in August is still on. Committeeman Germanio expressed his congratulations to the Cape May Tech Boys Baseball Team on their Championship.

Committeeman Cox indicated that he had no comments at this time.

Deputy Mayor Turner thanked Committeeman Germanio and Township Engineer, Mike Fralinger, for their efforts working with the County to get some improvements to the County Roads in Dennis.

Mayor Matalucci commended Public Works on the Township's field that are looking great and Committeeman VanArtsdalen concurred.
